Tournament Rules:

- Players will start with 15,000 in tournament chips.
- Players may do a one-time \$20 Dealer Appreciation Add-On for an additional 15,000 in tournament chips only at registration.
- A single ante will be paid from the big blind for each hand. If a participant doesn't have enough to post both, the big blind and the ante, the big blind will be posted first.
- On-Site Registration and unlimited Re-Entries are available until the start of Level 10 of this event. Approximately 8:15pm.
- If a player has been eliminated from the tournament, they may Re-Enter the event. Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
- Levels will last 20 minutes each. Seating may be limited for this event.
- Grand Poker Series Tournament and House Rules apply. Tournament Directors decisions are final and without recourse.
- Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters.
- Redraw at 27 and 9 players or at Tournament Directors discretion.
- Winners will be paid in casino chips.
- All tax laws foreign and domestic apply. Winners must show a valid ID to collect winnings. Residents of foreign countries without a U.S. tax treaty will be subject to withholding. Pursuant to IRS regulations, W-2G or 1042 forms will be issued for all tournament winnings of \$5,000 or more (net of buy-in amount).
- \$111 will go into the prize pool. \$39 is withheld for house administrative, staff fee and promotional fees.
- Of the \$20 Add-On, \$10 will go into the prize pool. \$10 is withheld for dealer appreciation.
- All unredeemed payouts past 30 days of the initial date of the tournament payout, those funds will be surrendered to the Grand Poker Series revenue.
